Both positions require a medical degree and board certification in Psychiatry (or ability to become certified in 24 months). Both positions are in the Behavioral Health Division of the Health and Human Services Department and provide care to children, adults, and families with behavioral health needs.





## *the* COMMUNITY

**H**OME TO OVER 379,000 RESIDENTS, Lane County stretches from the scenic Oregon Coast to the Cascade Mountains, with beautiful rivers and natural charm, the County is a great place to live, work and play. Oregon is known for its mild climate, natural environment, and ample recreational opportunities for biking, hiking, camping, kayaking, hot springs, and more. Located just an hour from the State's capital of Salem and two hours from Portland, Lane County offers proximity to the two largest urban hubs in the state while retaining its natural charm. The County Seat, Eugene, is consistently ranked as one of the best places to live in Oregon, and one of the best small cities in the United States. Eugene is also known as an epicenter of athletics and education. Home to University of Oregon and its iconic Autzen Stadium and Hayward Field, the County also includes Bushnell University and Lane Community College. The community is engaged and environmentally aware, with a focus on preserving the prolific natural beauty of the County. ## *the* COUNTY

**L**ANE COUNTY IS GOVERNED by a five-member Board of Commissioners who appoint a County Administrator to oversee day-to-day operations. The County has approximately 1,600 staff across 13 departments, and an annual budget of \$716 million. The County is guided by four Board-approved priority areas:

# DEPARTMENT OF HEALTH AND HUMAN SERVICES & BEHAVIORAL HEALTH DIVISION

**THE HEALTH AND HUMAN SERVICES (HHS) DEPARTMENT** has over 700 staff, a budget of \$142 million and is a consolidated department which includes behavioral health, social, and public health services under one department. The mission of the department is “to promote and protect the health and wellbeing of individuals, families, and our communities of Lane County.” HHS provides services through multiple divisions and programs:

**Behavioral Health Services’ (BHS)** mission is to enhance individual and family wellness through integrated care and community connections. BHS encompasses a range of services and programs for children, families, and adults to provide an integrated, holistic, multi-disciplinary team approach to serving individuals with moderate to severe mental and emotional difficulties. BHS has a budget of \$36 million, over 120 staff, and five teams comprised of psychiatrists, peer specialists, qualified mental health associates, and mental health providers. Each team has a panel of approximately 250 clients. These professionals serve the most vulnerable, persistently mentally ill patients. This division also contracts with nonprofit providers for assertive community treatment and wrap around services for our clients. The division contracts with a third-party mobile crisis unit and the County has a psychiatric acute care hospital.

BHS is a public mental health provider receiving funding from state mental health grants and client fees, some of which may be in the form of Medicaid, Medicare, and other insurance carriers’ reimbursements. We demonstrate through our actions a respect for our clients, a belief in their ability to achieve recovery and appreciation for diversity and individual differences. BHS services include:

- ▶ **Adult Outpatient Mental Health Services**
- ▶ **Child and Adolescent Mental Health Services**
- ▶ **Forensic Mental Health Programs**
- ▶ **Medication Assisted Treatment Program**
- ▶ **Adult Protective Services**

## MEDICAL DIRECTOR OF PSYCHIATRY

**THE MEDICAL DIRECTOR OF PSYCHIATRY** reports to the the Chief Medical Officer. The Medical Director oversees the medical side of the behavioral health services and oversees nine psychiatrists who provide mental health services to our clients. The position directs treatment and serves as the subject matter expert for staff and the community. The Medical Director splits their time between direct care, which includes overseeing clinical practice quality, reviewing the work of other psychiatrists, and administrative support (staff performance, timesheets, coverage, telehealth, resources, etc.), and overall care and delivery of these services through the development of programs, policies and procedures, and ensuring compliance with laws and regulations. This position also participates in budget and resource development, monitors funds throughout the year, and works as a team with administrative and support staff side of the division. The Medical Director represents the Department and County at meetings, public events, training sessions, committees, and responds to the media and other outlets as needed.

### *Our Ideal Medical Director Candidate...*

- ▶ Serves as the face of the agency with regards to community engagement and participation.
- ▶ Serves as the Mental Health Authority for the County and sets the tone of Behavioral Health in our community, and provides medical consultation to public and environmental health programs.
- ▶ Develops and delivers a vision for Behavioral Health Services in conjunction with the BH Division Manager.
- ▶ Assesses community behavioral health needs and develops a strategy to bridge identified gaps.
- ▶ Serves as community physician on behalf of all County residents.
- ▶ Communicates successfully with the media and takes an interest in public relations strategies.
- ▶ Maintains high visibility on community health issues and maintains cooperative relationships with others.
- ▶ Works with County, State, Federal and local government officials and the local medical community.
- ▶ Makes recommendations regarding legislation potential impact in public health policies.

## EMPLOYMENT STANDARDS

- ▶ A degree as a Medical Doctor in Psychiatry and five years of progressively responsible experience including supervisory experience,
- ▶ State of Oregon Medical License including dispensing privileges, or ability to become licensed,
- ▶ Board Certification by a recognized national board in Psychiatry,

- ▶ NPI,
- ▶ CPR/BLS by time of hire,
- ▶ Provide immunization records within 10 days of hire,

## GENERAL and/or FORENSIC PSYCHIATRIST

**T**HE PSYCHIATRIST provides outpatient care to individuals with a variety of psychiatric conditions, including severe and persistent mental illness. Responsibilities include psychiatric assessment, diagnosis, development and implementation of treatment plans, medication management and use of appropriate laboratory testing. Care is provided in a team-based model with therapists, case managers, and peer support specialists, in consultation with primary care and with patients' families and supports, with a caseload of up to 250. This position plays a vital role in the health of our community providing care for people in need, and provides services to adults, could work with individuals leaving jail for continuum of care, and works full time (however the County will consider a flex schedule, including working from home for telehealth during COVID).

### ***Our Ideal PSYCHIATRIST Candidate will...***

- ▶ Have a background and experience as a general, adult psychiatrist, and/or forensic knowledge or experience, to assist in managing a growing forensics program.
- ▶ Have knowledge, and ideally experience, working with mental health clients in the criminal justice system.
- ▶ Be passionate about the work we do.
- ▶ Periodically testify in the courts on the progress of treatment for clients.
- ▶ Take a leadership role in the Forensic Intensive Treatment Team and Mobile Treatment Program.
- ▶ Focus on outcomes-based metrics, and evidence based practices.
- ▶ Provide Telehealth services.

## EMPLOYMENT STANDARDS

- ▶ Graduation from an approved school of medicine with an MD or DO degree, completion of an approved residency program in psychiatry by time of appointment, and board certification as a Psychiatrist, or the ability to become board certified within 24 months,
- ▶ Three years of increasingly responsible clinical psychiatric experience by time of appointment,
- ▶ Possession of a valid State of Oregon license as an MD or DO,
- ▶ Possession of a Drug Enforcement Agency number at time of appointment,
- ▶ Immunization records within 10 days of hire,
- ▶ BLS/CPR by time of hire,
- ▶ Successful passing of a full criminal background check and drug screen.
