
### THE ORGANIZATION

THE COUNTY OF COMAL, TEXAS is run by a five-member Commissioners' Court consisting of four commissioners elected from single-member districts (called commissioner precincts) and a county judge elected at-large. The Commissioner's Court determines their office budgets and sets overall county policy. The County has 939 full-time staff and an approximate FY 2025 budget of \$162.2 million.

# THE CRIMINAL DISTRICT ATTORNEY'S OFFICE

THE DA'S OFFICE IS KNOWN FOR ITS EXCEPTIONAL TEAM CULTURE and strong morale. Staff enjoy a highly collaborative, family-forward environment where trial preparation and courtroom responsibilities are consistently shared across a well-supported team. Leadership provides hands-on guidance, and colleagues offer reliable support at every stage of a case. Weekly meetings, office celebrations, and informal team-building activities foster connection and pride in the work, cultivating a culture grounded in mutual respect, trust, camaraderie, and a shared commitment to public service.

In addition to offering great office culture and environment, the DA's Office serves as the chief legal authority for criminal prosecutions and legal counsel in Comal County, Texas. Handling approximately 5,100 cases annually, including over 1,400 felony indictments, the Office prosecutes offenses ranging from misdemeanors to serious felonies and plays a critical role in juvenile justice, victim advocacy, and protective orders. The Office includes 27 assistant district attorneys and 37 support staff, such as victim advocates, investigators, and clerks, and operates with an approximate FY 2025 budget of \$8.1 million. In 2021, the County added a fifth felony district court, and funding for the Felony I attorney of this court was recently approved. Each district court is supported by a felony I and felony II attorneys, investigator, victim advocate, and legal clerk, with additional oversight from a Chief Felony Prosecutor. The Office also administers programs like pretrial diversion programs, veteran's court, and a specialized court program for

certain alcohol and drug-related offenders. Through collaboration with law enforcement, the courts, and community partners, the Office works to deliver justice with fairness, efficiency, and integrity.

### THE JOB

Reporting to the Chief felony prosecutions from intake through trial and, when applicable, post-conviction and appellate proceedings. Core responsibilities include conducting legal research, drafting and litigating motions, presenting cases to the grand jury, negotiating plea agreements, ensuring discovery compliance, and handling all aspects of jury trials. Comal County maintains one of the highest trial volumes in the State of Texas due to the County's strong commitment to pursuing justice and a highly efficient criminal justice system that moves cases through the courts at a productive pace. With approximately 90 jury trials expected this year, the Attorney, Felony I will have an exceptional opportunity to work on high-profile and sensitive cases, including those involving child sexual assault, violent crimes, drug offenses, and organized theft. They will take the lead on case strategy, provide mentorship to junior attorneys, and collaborate closely with law enforcement and court personnel.



### Upcoming Projects & Opportunities

#### SPECIALIZED CASEWORK & LEGAL ASSIGNMENTS

Engages in complex, high-impact criminal prosecutions that offer opportunities to deepen expertise in specialized areas of law, including violent crimes, child exploitation, and white-collar offenses.

### THE IDEAL CANDIDATE

THE IDEAL CANDIDATE IS A SEASONED FELONY PROSECUTOR who demonstrates the ability to lead courtroom teams, shape effective case strategies, and mentor attorneys in a supportive and collaborative manner. Strong expertise of Texas criminal law and courtroom procedures are essential, along with effective trial skills in areas such as motion practice, jury selection, and courtroom presentation. The successful candidate excels at working with victims, law enforcement, and court personnel with professionalism, discretion, and respect. High emotional intelligence is critical for processing the emotional weight of challenging cases while maintaining a balanced and composed presence. They should possess a substantial trial record, having litigated felony jury trials and should have first- or second-chaired cases involving allegations of child sexual assault or similarly complex and sensitive offenses. This role requires uncompromising integrity, a strong work ethic, and a team-first mindset, all of which are vital for thriving in a high-volume, high-expectation prosecutorial environment.

#### The ideal candidate will also demonstrate the following core competencies:

**Presentation Skills:** Effectively communicates complex legal arguments in a clear, persuasive manner to judges, juries, and opposing counsel during trials, hearings, and motions.

**External Public Awareness:** Demonstrates an understanding of community expectations and the broader impact of prosecution decisions, maintaining professionalism in both courtroom conduct and public interactions.

**Organizing & Planning:** Manages high-volume caseloads with precision by prioritizing tasks, preparing for trial deadlines, and ensuring compliance with procedural requirements.

**Integrity:** Upholds the highest ethical standards in all prosecutorial actions, consistently demonstrating fairness, objectivity, and accountability in the pursuit of justice.





### MINIMUM QUALIFICATIONS

**Education:** A Bachelor's degree from four-year college or university and a J.D. law degree are required. Pass the Texas Bar Exam.

**Experience:** Three (3) years of experience as an attorney practicing criminal law. Significant Felony Jury trial experience. The individual should possess a thorough working knowledge of law enforcement and court procedures and practices.

**Certification & License:** The individual must have a Texas Law license.
